You Can Relax Knowing Your Contents Are Protected

At 1-800-PACK-RAT, we will always use our best efforts to keep your property safe and secure. However, sometimes events can occur that can damage your property. We offer a contents protection plan which provides coverage for damage or losses to your personal property while stored in our container.

Like all self-storage, portable storage, and moving companies, we are not responsible for the items stored in our containers as we do not know what is stored nor are we in control of how items are packed. If you do not have homeowner's coverage or if you are not sure that your homeowner's insurance covers your property while in our container, our contents protection plan is a cost

effective solution. If you do have homeowner's coverage, deductibles typically run in the \$ 1,000 - \$2,500 range. Our deductible is \$100. In the unlikely event of a claim, your costs will be lower with our plan. Our plan also carries a damage waiver to cover any damage to the container itself. Our program is designed to provide you with peace-of-mind for the protection of your valuables.

What We Offer

The Basic Plan is our damage waiver plan that covers damage to the container when in your possession. If you select this option, you are not responsible for any damage to the container itself.* The basic plan does not protect your belongings.

The Silver Plan combines the Basic Plan with protection for your contents within the container. If you select this option, you have up to \$75,000 of protection for your household goods and personal effects while the container is in 1-800-PACK-RAT's possession or at your location.*

We will assume responsibility for damage or losses to your property caused by:

Fire or Lightning, Wind or Hail, Smoke, Weight if Ice, Snow or Sleet, Vandalism and Mischief, Falling Object, Collapse of the Warehouse, Collision, Overturn of truck, Overflow of water, Upset or overturning of the Container, or Burglary (excluding when the container is on-site at your location) with evidence of forcible entry to the Container.

*Subject to the conditions and exclusions listed in the Rental Agreement

What is not Covered?

We will not be obligated for loss caused by or resulting from any of the following:

- The storage or placement of items in the Container that are not to be stored or placed in the Container (as listed in the Rental Agreement)
- Intentional acts by you to the contents or the Container
- Damage caused by improper packing or normal shifting

Deductible

There is a \$100 deductible for all losses excluding damage caused by Named Storms (Hurricanes), for these occurrences there is a \$2,500 deductible.

In the Event of Loss or Damage to the Property

If an event does occur that causes loss or damage, please call 1-800-PACK-RAT, be prepared to include a description of the property involved and a description of how, when and where the loss or damage occurred. If a law may have been broken, notify the police and file a report immediately.
